

Scoot KrisFlyer Global Redemption Sale Terms and Conditions

1. This is the Scoot Pte. Ltd. ("Scoot") KrisFlyer Global Redemption Sale promotion ("Promotion"). The promotion is open to KrisFlyer members ("Participants") for the online redemption of discounted award flights in Economy only, on selected Scoot operated flights ("Promo Award Flights"). Please refer to the list of eligible Saver Award Flights and the discount to be applied to these flights, in the [campaign landing page](#). The promotion is not valid for codeshare flights.
2. Eligible bookings can be done through [flyscoot.com](#) or Scoot mobile app. This service is not available via Scoot's Hotline, KrisFlyer Membership Services or Singapore Airlines Reservations and Ticketing offices.
3. The Promo Award Flights must be redeemed during the period stated, for the travel during the periods stated, in the [campaign landing page](#).
4. Promo Award Flights are subject to seat availability at the time of redemption. Waitlist is not permitted.
5. Route changes are not permitted. Date changes are permitted, subject to additional service fees and award availability. Award level difference may be payable. If the new journey requires fewer KrisFlyer miles, the excess shall not be refunded.
6. This promotion cannot be combined with any other discount or promotion.
7. This promotion is applicable to one-way and round-trip travel.
8. Taxes, surcharges and fees are applicable in addition to the redemption mileage required. Add-ons may be purchased separately for award flights. Add-ons, taxes, surcharges and fees are payable in the currency prescribed with our published fares, unless stated otherwise.
9. The Promotion will only apply to flights purchased entirely with KrisFlyer miles. It does not apply to commercial flights purchased with part miles, part cash.
10. The discount level is only applied on the number of KrisFlyer miles required for an Economy Class Saver award flight. The discount will be displayed upon selection of eligible flight(s) under the "Scoot Promo" category during booking on [flyscoot.com](#).

By participating in the Promotion, each Participant agrees to comply with and be bound by these terms and conditions, Scoot's conditions of use of website, Scoot's Privacy Policy, and the KrisFlyer Terms and Conditions (collectively, "Scoot Terms & Conditions"). any stage of the Promotion, and any discounts on KrisFlyer miles redemptions awarded may be forfeited, withheld, withdrawn or reclaimed.
